AN ORDINANCE TITLED THE ANNUAL APPROPIATION ORDINANCE FOR THE FISCAL YEAR BEGINNING
OCTOBER 1, 2023, APPROPRIATING THE SUM OF \$1,389,300.00 TO DEFRAY THE EXPENSES AND
LIABILITIES OF THE CITY OF ARCO FOR THE SAID FISCAL YEAR, AUTHORIZING A LEVY OF THE SUFFICIENT
TAX UPON THE TAXABLE PROPERTY AND SPECIFIYING THE OBJECT AND PURPOSED FOR WHICH SAID
APPROPRIATION IS MADE.

BE IT ORDAINED by the Mayor and City Council of the City of Arco, Butte County, Idaho SECTION 1: That the sum of \$1,389,300.00 be, and the same is appropriated to defray the necessary expenses beginning October 1, 2023.

Section 4: All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed.

Section 5: This ordinance shall take effect and be in full force upon its passage, approval, and publication in one issue of the Arco Advertiser a newspaper of general circulation in the City of Arco, and the official newpaper of said City.
